### **PRESIDENT'S REPORT**

Ladies and Gentlemen,

1974/75 has been a year of consolidating the affairs of our Association.

As you are all aware the basis of any Incorporated Society is a practical, comprehensive and fair Constitution. Our first Constitution was drafted in 1926 and subsequently revised in 1958. This year the Constitution has been redrafted and will be submitted for your approval. It has always been accepted that the Central Body is in fact the parent body of all local branches. This role has been maintained in the revised draft. However, considerable effort was spent in maintaining a certain degree of autonomy at branch level within the ideals of our Association. Many clauses have been updated and revised.

A telephone and address directory has been completed and forwarded to members throughout New Zealand. Such a venture is always complicated by postal changes in local areas, hence it is difficult to achieve absolute accuracy. Notwithstanding this I am sure the directory will be of considerable benefit to members.

It was a tragic occasion for New Zealand when Norman Kirk unexpectedly passed away in Wellington. At 51 he had not fulfilled his capabilities and his demise has left New Zealand bereft of a humanitarian statesman and of our people a friend. It is gratifying that his position has been filled by Mr W.E. Rowling and that the basic humanitarian policy in maintaining equal dignity and integrity for people of every colour and race is being strongly reaffirmed. I quote a cable from the Prime Minister, the At. Hon. W.E. Rowling acknowledging our congratulatory message

“Mr Tizard and I will continue the late Mr Kirk’s work to bring New Zealand to Nationhood. A country of all who make their home here.”

The Government’s new Immigration Policy rectifies certain anomalies which have been causing

concern to our members. It would appear that families which have in the past been separated may now be re-united. Special provision has also been made for admitting relatives and others on humanitarian grounds.

The international scene is at present in a state of uncertainty. The diversion of immense wealth to oil producing countries has posed grave economic problems for most western and underdeveloped countries. Governments have introduced monetary and fiscal policies of varying seven-ties to combat inflation and maintain stability. New Zealand has as a result of this and E.E.C. policies faced a relatively mild-recession. It would appear that this dampening of the economy may persist for some time. I am sure that our members will play their part in contributing towards the welfare of New Zealand.

In conclusion I would like to thank the Officers and Executive members for their co-operation and assistance.
