PRESIDENT'S REPORT

NAMASTE, SAT-SHRI-AKAL AND WELCOME DELEGATES, LIFE MEMBERS AND HONOURED GUESTS.

It is with much pleasure I present my annual report to the New Zealand Indian Central Association.

This year has been very interesting for our Association and our members have been involved in many activities throughout New Zealand.

Some of the more notable ones are:—

1. The Royal visit by the Queen and Duke.
2. Change of leadership in the National Party.
3. Formation of the Auckland Ethnic Council.
4. The Investiture of Mr J.K. Natali by the Queen for his Queen Service Medal.
5. Life Membership function in Auckland — where I took the opportunity to unofficially welcome Admiral Dawson.
6. World Day of Prayer for Peace:
7. Golden Jubilee Celebrations for the Wellington Sports Club.
8. Laying of Foundation Stone for the Gurdwara in Otahuhu.

A very shameful action was the bombing of the Greenpeace flagship — Rainbow Warrior. This was a deliberate act of terrorism by a foreign country in our beautiful peaceful harbour.

This type of behaviour cannot and should not be tolerated by any person or country, especially with loss of life involved. We offer our condolences to Greenpeace and the family of the crew member who lost his life.

We also offer our sympathy to Mr and Mrs Nagin Patel who lost their only Son in such tragic circumstances. What was meant to be a joyous musical feast — the visit of Anup Jalota was marred by this unfortunate tragedy. We have no answers but we offer our prayers. Our condolences also to Unka Chibha and his family in the sad demise of his Mother.

1986 is designated by the United Nations as the ‘Year for Peace’. As Indians our heritage and inbred tolerance commits us to peace, so the Government stance on keeping New Zealand a ‘Nuclear Free Zone’ is very acceptable to our Indian thinking. We all know that knowledge once acquired cannot be unlearned but we must insist that it be used for the progress and betterment of mankind, and not allow knowledge in any form to destroy us, and our environment. Our Prime Minister was indeed a credit to New Zealand at the Oxford debate on the ‘Nuclear Issue’, where his skill was acclaimed by all present. We congratulate the Rt. Hon. David Lange on his excellent performance.

Since our last meeting we have farewelled Hiwi Tauroa, the Race Relations Conciliator. Hiwi was a good friend to our community and we thank him for putting Race Relations on the map and for making people aware of the existence and needs of Ethnic minorities in New Zealand.

It is with much pleasure I welcome the new Conciliator, Wally Hirsh, a very astute caring man, who I’m sure will continue to build on the work of the people before him.

Recently in Auckland we were very pleased to host the Kathakali dancers. I congratulate the Auckland

Indian Association and the Fiji Association, especially Mr Satendra Singh for arranging this concert at such short notice. We can achieve so much more by working together.

We should all be pleased to note that the planned Rugby tour of South Africa did not go ahead. I would like to thank you all for your support and hope this cancellation will serve as yet another blow for 'Apartheid'. At least our efforts were not in vain.

Not so long ago we said farewell to Mr Kievom, the Acting High Commissioner for India and his family. His casual friendliness and beaming smile will be missed by us all.

I would like to welcome Admiral Dawson, the High Commissioner for India to the New Zealand Indian community. I have had the pleasure of meeting Admiral Dawson on many occasions and am most impressed with his approachable courteous manner. I'm sure he will continue and develop the meaningful relationship with the Indians in New Zealand as did his predecessor.

With so much unrest in the World today, I must stress the need for unity, unity within our family, our community and within our Association. The New Zealand Indian Central Association is only as strong as our branches, so I would like you to return to your various Branch Associations with renewed vigour and enthusiasm so that we may encourage our youth to take more interest in all our affairs. The only way to preserve our culture and customs is by having pride in ourselves and our identity. If we can engender this feeling of pride, love and care in our children, we will progress as people and as Indians.

I would like to thank my Executive Committee, all Branch Presidents and Officers for their support, and presence at the Executive meetings. ANNUAL CONFERENCE

The Host President Santokh Singh Bhullar welcomed the honoured guests, delegates and Life Members and wished them every success in their deliberations.

Prime Minister (Mr Lange), was to be the guest speaker, but because he was on an Overseas mission, a Video Recorded message was played to the delegates. In his message the Prime Minister stated that he has a long association with the Indian Community in N.Z. and Indians in India. He has made several trips to India and has met many Indian Dignitaries. He has also met and discussed with Rajiv Gandhi (Prime Minister of India), various matters dealing with economy, new technology, and trade between the two countries. The relationship between India and N.Z. was strengthened by the re-opening of the N.Z. High Commissions Office in New Delhi.

Mr Santokh Singh Bhullar then introduced the Indian High Commissioner to N.Z. Admiral Dawson, who addressed the Conference.

Admiral Dawson stated that he was indeed happy to see that the Indians in N.Z., through their hard work and effort, have become well settled in N.Z. and as an Ambassador he was delighted to hear and learn that Indians are well respected in N.Z.

He told the Conference that India has made great success in the field of Science and Technology, Farming, Business World and Foreign Policy. He stated that India's progress is marred at times by internal strife, fight for secular states and natural calamities. In spite of these problems, the harmony and co-existence that thrives in a vast country, with a multitude of languages, religious, traditions and customs, is a credit to its people and the country.

He told the delegates that Indians should assimilate in the N.Z. Society, but must retain the traditional culture, particularly amongst the younger generation.

In conclusion Admiral Dawson wished the Conference every success in the deliberations and declared the meeting open.

In reply the Vice President Manganbhai Ranchhod thanked Admiral Dawson for attending the opening session of the Conference and enlightening the delegates with India's progress, inspite of internal problems.

The President Shantiben Thakor presented Admiral Dawson with a copy of the Historical Book "Indians in N.Z." and adjourned the meeting at approximately 10.45 a.m. for tea break.

The main Conference commenced at 11.15 a.m. The Youth Conference also commenced about the same time at the Te Rapa Hall.

Two minutes silence was observed as a mark of respect for those members who had passed away during the year. In particular a special tribute was paid to one of our prominent Life Members, Mr Govindbhai Kanji (Wellington) who passed away recently.

Minutes of the 59th Annual Conference held in Rotorua on 6 April 1986 were read and confirmed. (The General Secretary apologised for handing out the Delegates in error reports of Conference held in Auckland instead of Rotorua).

MATTERS ARISING OUT OF MINUTES

Matters arising out of minutes:

(1) Telephone Directory

Maganbhai Ranch hod was appointed to investigate the printing and cost factor of New directory. He briefly outlined his findings. The matter was discussed at great length and the following resolution was passed:-

“That the association organise printing of a new Directory and the preliminary information for Directory from all the branches be in the hands of the General Secretary by 30 August 1986.”

It was also passed that the Branches to obtain advertisements, to cover cost of printing, from members or non members, in their respective areas.

Concerning the advertisement charges, it was moved:

“That \$250 will be charged for inside ordinary pages and in respect of

- (i) Inside front page
- (ii) Inside back pages and
- (iii) Back page

the Branches are to call for tenders through their circulars to members, or by canvassing amongst the non-members for the highest tenderer (in excess of \$250) who will be given first

preference.

Inward and Outward Correspondence:

The following inward and outward letters were tabled:

1. Letter to N.Z. Press Council concerning an article in the N.Z. Herald which singled out Indian Landlords in the Auckland area. The Association raised an objection to this article.
2. Letter from the N.Z. Press Council stating that the complaint should first be referred to the Editor of N.Z. Herald.
3. Letter to N.Z. Herald expressing our concern to the article in the Herald which singled out Indian Landlords.
In their reply it was stated that the articles are “closely evaluated” before they are published. As the reply was not wholly satisfactory, the matter has now been referred to the Ethnic Council in Auckland for their investigation.
4. Letter to the Minister of Internal Affairs (N.Z.) re Dual Citizenship. The reply from the Minister stated that as far as N.Z. is concerned, a person may simultaneously be a citizen of one or more other countries as well as N.Z.
5. Letter to the Minister of Broadcasting and the Director General, B.C.N.Z., requesting time to be allocated for presenting Indian programmes on Radio and Television.

Reply from the Minister stating the matter had been referred to the Broadcasting Corporation.

Reply from the Director General T.V.N.Z. states that there is a need to recognise many minority groups settled in N.Z. Possibility of including Indian programmes is being investigated.

Reply from the Director General Radio N.Z. states that the Indian Community is recognised as one of the, many minority groups that make up and contribute to the modern multicultural society. He stated that 2YB access already provides regular Sunday evening programmes by and for the Indian community. A Q similar access station will be established in Auckland in the near future.

6. Letters to and from the Indian High Commissions Office in Wellington re:—

(a) Dual Citizenship

Indian constitution does not permit dual nationality.

(b) Visas for India

All foreign nationals including N.Z. Passports holders need visa for India before they depart.

(c) Indian Cultural Scholarship

It was confirmed that scholarships' on various courses are available which are normally channelled through the recipient country.

7. National Superannuation:

A letter to Minister of Social Welfare enquiring about payment of National Superannuation to New Zealand Citizens/Residents wishing to retire overseas.

The Minister replied stating that the issue will be examined by the Royal Commission on Social Security.

8. A letter from Wellington Indian Sports Club inviting the President and Secretary to its Golden Jubilee (50th Anniversary) Celebration.

9. Q.S.M. and Q.S.O. Award

Mr Kantibhai Soma (Wellington) expressed his concern in the way the nominations for QSM and QSO awards were processed at previous meetings.

After a lengthy discussion on the subject, two nominations from Auckland Branch, that of Mr Rameshbhai Patel and Mr Shivlalbhai Masters were put to vote by secret ballot. They did not succeed in getting 2/3 majority of the votes, therefore the names were not forwarded to the N.Z. Government for consideration for Queen's Award.

The meeting suggested that the names be re-nominated by the respective Branch Association and the General Secretary is to call for any other nominations from Branches.

Life Membership

(Discussion was chaired by Maganbhai Ranchhod).

A letter from Auckland Branch, nominating Mr Thakorbbhai Parbhu for Life Membership, together with a resume was tabled.

The President pointed out that the nomination was received and considered at the last Executive Committee meeting held in Wellington and it was recommended, unanimously, that the name be forwarded to the next Annual Conference for consideration.

Various members spoke on Mr Parbhu's contribution to the Association and the community.

On a secret ballot more than 2/3 of the delegates voted in favour of Mr Parbhu's nomination and hence he was duly made a Life Member and was presented with the Life Membership Badge.

Santokh S Bhullar/Raman Ranchhod

Prior to commencement of the Meeting, Mr David Robinson, who is a Social Research Consultant, appointed by State Services Commission, was given an opportunity to address the meeting. He has been employed to do a research on “Provision of Government Services to Ethnic Minority Groups”, and whether these services meet their needs.

The two main areas that his survey is concerned with are:

- a) The access to and use of Government Services that are provided for all New Zealanders.
- b) The needs of different ethnic groups that may require a special Government programme or other action.

The topics covered in his research are “Immigration, Employment, Housing, Education, Health, and Social Welfare.

He stated that he has met many groups and has discussed the above-mentioned topics — what effect it has; any improvement that could be made. He is hoping to submit a report on his findings to the Government.

With regards to Education, Mr Robinson was advised that we would like our children to learn our language and thus maintain some of our culture. The difficulty faced in this direction is that we do not have teachers who can satisfactorily provide this service. Therefore he was asked to make a representation on our behalf to the Government, of either providing funds or teachers whereby regular classes can be held to teach Hindi or Gujarati.

After a half hour talk and general discussion, the main meeting commenced at approximately 2.30 p.m.

Mr Raman Ranchhod, Vice President of Wellington Indian Association (the Host Association) welcomed the members and wished the meeting every success.

Two minutes silence was observed as a mark of respect for those members who had passed away recently. Particular mention was made of one of the long-standing Life Members, GOVINBHAI KANJI (Wellington) who passed away recently.

Minutes of Meeting held in Auckland.

It was moved that the Minutes of Meeting held in Auckland on 27 July 1985 be accepted as read.

Matters Arising out of Minutes

Immigration

Amrit Vasan (Chairman of the Immigration Committee) reported that as the Draft Bill on Immigration had not yet been published, there was very little to report. However, he stated that the Committee would meet the Minister of Immigration and discuss the Draft Bill yet to be published.

OSM or QSO Award

The President stated that she had communicated with the Prime Minister's Secretary re our nomination for the award. She was advised that the matter is under consideration.

Correspondence

From Television New Zealand.

As regards to supplying dates and titles of Indian programmes to be screened on Television, the Executive Assistant (Programming) of BCNZ advised that it is not possible to catalogue titles with ethnic content.

As for screening of Indian Programmes, the Director-General advised that because the majority of the audience are English speaking, they must cater for majority.

From Radio New Zealand.

In reply to our enquiry of providing Indian programmes on Radio New Zealand, the Director-General advised that the Indian Community is recognised as one of the many minority groups that make up and contribute to the modern multi-cultural society. In 1981 Radio NZ set up the 2YB Access Station in Wellington and through this station a regular Sunday Evening programme by and for the Indian Community is already broadcast. Radio NZ intends to establish a similar Access Station in Auckland to service the ethnic group in this area.

NZ Press Council

The Article which appeared in the NZ Herald on 26 January 1985 concerning Housing in NZ seemed to single out Indian Landlords.

Our objection to this article was made to the NZ Press Council and the NZ Herald. As the reply from NZ Herald was not very satisfactory, it was moved that the matter now be referred to the Ethnic Council.

National Superannuation

The Correspondence to and from the Minister of Social Welfare concerning portability of National Superannuation was tabled at the meeting. After a brief discussion it was resolved that the three people appointed to Committee on Immigration be authorised to prepare a submission to be forwarded to the Royal Commission on Social Security.

Life Membership

A letter from Auckland Branch together with Resume on Mr Thakorbbhai Parbhu, whose name was nominated for Life Membership was tabled for discussion.

Thakorbbhai Parbhu who was present at the meeting was requested to absent himself during the discussion and Mrs Shantiben Thakor (President) handed over the Chairmanship to the Vice-President Mangambhai Ranchhod in the interim.
