PRESIDENT'S REPORT

Namaste, Sat-Shri-Akal, and welcome delegates, life members and honoured guests.

We have been honoured with the visit of the Prime Minister of India, Rajiv Gandhi and his wife Sonia. This visit not only enthralled the people of New Zealand but really cemented the relationship between India and new Zealand. My real disappointment during this tour was that many of our members were not able to meet this charming couple. My sincere apologies to our senior life members for this sad omission but circumstances were beyond my control.

The Pope's visit added a spiritual dimension to the Catholic community of New Zealand and many were blessed by his presence.

Recently I was invited with the Prime Minister, to the 'Blessing of the Earth' ceremony to lay the foundation for 'Bhakti Bhavan' by the Hare Krishna Society. The Rotorua, Bay of Plenty Indian Association recently acquired a Community Centre of their own. I really am grateful for the invitation to partake in the moving occasion of their opening. I wish them well in their future endeavours, and know this centre will be a gathering place for the future generation of Indians in Rotorua/Bay of Plenty area. A very proud moment for Indians throughout New Zealand was the selection of Deepak Patel for the New Zealand Cricket team, we all wish him a bright, exciting future.

Recently in Auckland we had the pleasure of 'Access Radio', although on a short term warrant, it gave many ethnic groups the chance to hear their own language and music on the air waves.

It was very pleasing for me to note that some Indians were holding key positions in the National Federation and Labour Coalition Party, who won the recent Fiji elections. I hope their support for our 'Nuclear Free' Policy may lead to World Peace.

It is with deep sorrow we mourn the passing of Rambhai Unka a valued life member. We have all enjoyed Rambhai's hospitality over the years. On behalf of us all I offer Rambhai's family our deepest sympathy and condolences. He will be sadly missed by us all.

My sincere appreciation to the Wellington and Auckland branches for hosting our Committee meetings during the year.

Once again I stress the need to preserve our own identity as Indians. We have an ancient civilisation which has survived the ravages of time. Our religion is our way of life, and sharing and caring is an integral part of our culture.

ANNUAL CONFERENCE

The host president Chhotubhai Chhiba welcomed the honoured guests, delegates and life members and wished them every success in their deliberations.

Mr Gulab Moral then introduced the Mayor of New Plymouth Mr David Lean who addressed the conference. The Mayor welcomed the delegates and stated that he was indeed happy to see that the association chose New Plymouth as the venue, to hold the 61st Annual Conference. He briefly outlined the progress of Taranaki in agriculture, farming and oil industry. He also stated that though the Indian population in Taranaki is small in number, their contribution towards the economic growth and social welfare is greatly appreciated.

In conclusion, he stated that Indians are law abiding citizens and have well assimilated in the society. He wished the conference every success in their deliberations and declared the meeting open.

In reply the vice president Mr Santokh Singh Bhullar thanked the Mayor Mr David Lean for attending the opening session of the conference and declaring the meeting open.

The president Shantiben Thakor presented the Mayor with a copy of the historical book “Indians in NZ” and adjourned the meeting at about 10.00 a.m. for morning tea.

The main conference commenced at 11 a.m.

Two minutes silence was observed as a mark of respect for those officers who had passed away during the year. In particular a special tribute was paid to one of our life members Ramabhai Unka (Hamilton) who passed away recently. Pravin Puna (Waikato) read the obituary (printed in this report) on Ramabhai. Various delegates paid tribute to him.

At this stage one of the observers Mr Parbhubhai Soma Patel (a visitor to NZ from Dandi, India) was given permission to address the conference.

Parbhubhai Patel, one of the freedom fighters during the Quit Indian Movement, said that he had heard a lot about New Zealand and was in New Zealand visiting relatives and friends, he was happy to see the progress made by Indian settlers over the years in New Zealand and pleased to see that they had prospered and well settled in New Zealand.

YOUTH GROUP

During the opening session, the chairperson, Miss Harpreet Sardool Singh of the youth group was given an opportunity to address the meeting.

She expressed her grave concern by stating that, this year, apart from one or two minor branches representing the youth conference, the lack of participation was most disappointing, particularly from larger associations. Because of lack of interest, she suggested that the youth group should go into recession until interest is renewed.

Various members expressed their views on youth inactiveness and how to generate and motivate youth to participate in the activities.

Rameshbhai was presented with a merit certificate for attending 15 or more conferences.

It was again suggested that in order to update the association's record anyone who has any information pertaining to the association, beyond 1952, should forward copies to the general secretary.

2. Letter to Minister of Foreign Affairs, re visit by the Prime Minister of India, Rajiv Gandhi.
3. Letter from Minister of Foreign Affairs advising that the official visit by India's Prime Minister is being handled by Internal Affairs.
4. Letter to Indian High Commissioner in Wellington advising him of our concern for not inviting members and all the Life Members and for not giving the President (Shantiben Thakor) an opportunity to speak at the function held in the honour of Rajiv Gandhi.
5. Letter from Mayor of Auckland (Cath Tizard) seeking assistance towards the upgrading of elephant house at the Auckland Zoo.
6. Letter from N.Z. Sikh Society concerning an incident, where the Customs Department at Auckland airport had asked a group of musicians from India to leave their tabla (drums) behind for fumigation etc.

7. Letter to Customs Department enquiring of their policy in the matter.
8. Letter from the Customs Department stating the matter has been referred to the Ministry of Agriculture and Fisheries.
9. Letter from M.A.F. advising that it is the requirement of Ministry to fumigate such articles to protect against animal disease.
10. Letter from Savita Rupa with copies of letters written to Auckland Branch seeking their support in order to get council approval to erect a building with elephant design.

Q.S.M. or Q.S.O.

This matter was discussed together with the remit from Auckland:

REMIT “That the existing criteria of 2/3 majority requirement for a nominee for the Q.S.M. or Q.S.O. be abolished.

Various members expressed their opinion on the remit and after a lengthy discussion a voting was taken by ballot.

On a ballot voting the remit was carried by a majority vote (36/26). Having abolished the 2/3 majority requirement, the conference tabled three nominations for consideration, that of Shivilalbai Masters and Rameshbhai Patel (Auckland) and Narsinhbhai Vallabh (Wellington).

Resume of all three nominations was read out first and then the method of voting was debated at great length. After a lengthy discussion on the method of voting the following motion was moved:

THAT all three names be considered by this Conference and the nominee receiving highest vote be recommended first and the second and third highest be recommended at six monthly intervals.

Sub Committee on Immigration and Social Welfare

The following were renominated:

Amrit Vasan, Raman Ganda, Thakor Parbhu, Santokh Singh Bhullar and Ganges Singh.

Report on Immigration and Social Welfare

Chairman of the sub-committee Mr Amrit Vasan in outlining a brief report stated that the Act on Immigration is under review. That the members should press upon their local MPs for liberalisation of policy on family reunification.

He also stated that the policy should be more flexible on degree of competency.

With regard to portability of National Superannuation he stated that the matter is under consideration by the Royal Commission on Social Welfare and Superannuation.

BRANCH ACTIVITIES

Each branch presented its report on the activities carried out throughout the year.

Most branches were involved in charity fund raising, Gita classes, festival celebrations, social and cultural activities. Mahila Samaj also played an active and important role in promoting and preserving our culture in their respective branch associations.

REMITTS

REMITTS

From Auckland:

1. "That the number of Life Members of N.Z. Indian Central Association be increased from 15 to 20."
Carried
2. "The Auckland Indian Association is disappointed and dismayed in the way the High Commissioner of India handled the Indian Prime Minister's visit to New Zealand."

Various members spoke on this subject showing their concern at the lack of opportunity given to members of the Association to meet the Prime Minister Rajiv Gandhi. Those who spoke on the subject indicated that the High Commissioner had failed in his obligation towards the Association members

and had done injustice to them for not being invited to the function.

3. “Any person travelling to and from India to New Zealand should be allowed to carry two suitcases regardless of weight — same as in America and other countries.” Carried

4. “The existing voting criteria of 2/3 majority requirement for a nominee for the Q.S.O. or Q.S.M. award be abolished.” Carried

GENERAL BUSINESS

1. “That in future an invitation be extended to the High Commissioner of India at every Annual Conference.”

2. Re Estate of Deceased ,

With the meeting’s approval, Deviben Ramesh Patel of Taranaki gave a brief account on status of children affecting estate of deceased; e.g. custody and control of children, property, assets etc.

The conference did not discuss the matter, but suggested that the subcommittee on Social Welfare to consider the issue when they meet next.

3. School Certificate Marks

Mr Gowardhan Mehta informed the Conference that as from 1987 schools will not be supplying marks to the students for School Certificate results.

After a lengthy discussion on the subject, the following motions were moved and passed.

(a) “That we write to the Minister of Education enquiring of their policy on providing marks for School Certificate.”

(b) “If the marks for School Certificate exams are not available then as from 1987 prizes be awarded for Bursary Exams.”

4 .Idea Exchange

Ranchhodbhai Kana (Pukekohe) briefly outlined the value of publication “Idea Exchange”. It was his opinion that every Branch should subscribe for this publication which cost £10 stg for two years.

5. Mr Chhotubhai Sima (Auckland) informed the conference that he was concerned to read an article in New Zealand Times of 25/1/87, which in his opinion gave a false name and account of people involved in fighting for India’s Independence.

After a brief discussion on the matter, the President pointed out that, it appears the article was an extract from the Historical Book “Indians in N.Z.” published by Dr Tiwari.

6. Mr Ganges Singh informed the meeting that the following people who were appointed Justices of the Peace, be recorded in the minutes.

- (i) Tilak Chandra (Country Section)
- (ii) Gulab Moral (Taranaki)
- (iii) Satendra Singh (Fiji Association)

7. Representation by Christchurch Association

Once again members expressed their concern at lack of representation of the Conference or Executive Committee Meeting, from the Christchurch Association.

It was suggested that the Association should write and enquire, the reason why the Christchurch Association has not sent any representation in recent years.

8. Issue of Visa

Mr Chhimabhai Vallabh (Auckland) informed the Conference of a recent incident where one of the members received an urgent telegram from India stating his mother was very ill and to come to India immediately. While his visas application was being processed at the High Commission's Office in Wellington, he received another telegram stating that his mother had passed away.

On the strength of incidents like this, it was suggested that we write to the Indian High Commission's Office in Wellington requesting him that a responsible person be appointed in Auckland, who would be authorised to issue visa in emergency only.

9. Renewal of Indian Passport

It was brought to the notice of the meeting that many members with Indian passports do not take any action to renew their passports until the date expires. Therefore members should, from time to time, check the expiry date of their passports and have it renewed before it expires.

10. Payment of Affiliation Fees

It was moved that the secretary should write to all branches by 30th September each year, stating that their membership fee is due and that it should be paid by a specific date.

IMMIGRATION

Amrit Vasani stated that there was nothing to report at this point of time. However after a brief discussion on the matter it was suggested that the subcommittee to meet Richard Northey (chairman of the Caucus committee on Immigration) and have a preliminary discussion on proposed Immigration Bill yet to be published.

CONFIRMATION OF MINUTES

Minutes of the meeting held in Wellington, circulated to all the Committee and Life Members prior to the Executive Committee Meeting, were confirmed as true and correct record.

CORRESPONDENCE

The following letters tabled at the meeting were discussed and appropriate actions taken:

1. Letter from the High Commission of India re Insurance of Visa and Unaccompanied baggage. The members felt the reply was inadequate and unsatisfactory. After a lengthy discussion on the subject it was agreed that we write to the High Commission's Office in Wellington pointing out that though the Visas are issued from 'Wellington there is a considerable delay in processing and issuing Visas. Request the High Commissioner that he instruct his staff to expedite the Visa applications. It was also pointed out that recently when one of the members was visiting India he was asked by the Custom's Officer if he had a permit to carry a Video Camera with him. The High Commission is to be asked to clarify the permit requirements for Video Cameras.
2. A letter from Hemant Vimal Sharma of Fiji offering his services as a Hindu Priest.
3. Letter from Mayor of Auckland informing of the gift of two elephants (to the NZ High Government) by the Indian Government, and seeking donation for upgrading of elephant house at Auckland Zoo.
4. Letter from Madhur Malik seeking information concerning placing of advertisement in personal column in local news media.
5. Letter to the Minister of Foreign Affairs, N.Z., concerning visit to N.Z. by the Indian Prime Minister and an acknowledgement from the Minister's office. The President advised the members that the function held in the honour of Rajiv Gandhi in Auckland on 19 October 1986 was hosted and organised by the High Commissioner of India.

The members expressed their concern and disappointment at being discriminated and it was reported:—

- (a) That two Life Members, namely Karam Singh Basi and Piara Singh, whose names were

supplied to the High Commissioner together with names of other Life Members, were not invited to the function held at Auckland on 19 October, 1986.

(b) That the President was not given an opportunity to welcome the Prime Minister, Rajiv Gandhi, on behalf of the Indians in N.Z., at the function held in Auckland on 19.10.86.

(c) At the lack of opportunity given to the Association to host a meeting a function in honour of the Prime Minister, Rajiv Gandhi.

(d) A letter be written to the High Commissioner bringing the above matters to his notice.

REPORTS FROM SUB COMMITTEE ON:

1. IMMIGRATION

Mr Ramanbhai Ganda briefly outlined the proposed submissions on new Immigration Bill to be presented to the Select Committee.

He stated that the new Bill which is to be passed by the Parliament will become the law when passed and the Policy which is effective now can be modified as and when required.

It was suggested that Branches be asked to send any submission on Policy changes to the Chairman of Sub Committee by 31.12.87.

2. PORTABILITY OF SUPERANNUATION (PENSION)

The President advised that the whole concept on National Superannuation payment is being looked at by the Task Force and their findings will be made known to the republic.
